Agreement Acknowledgements

In consideration of entering into a contract with the *Niagara Falls School of Drama* (also referred to as NFSD), I hereby acknowledge and warrant as follows:

- a) I acknowledge that classes begin on *Sept 12/15, 2023*, and conclude *May 28/30, 2024*, and the contract will be in effect and follow in accordance to the dates stated above, in addition to the following Terms and Conditions.
- b) I acknowledge that cancellation of drama classes should be done on or before *October 3rd, 2023*, for Tuesday classes or *October 6th, 2023*, for Friday classes. This applies to **new** students only.
- c) I acknowledge **all** students must submit the balance of class fees or submit post-dated cheques for Instalment Plans A or B, or sign an E-Transfer Agreement, on or before the dates listed in b) and that there are *no refunds for classes cancelled after this deadline*.
- d) I acknowledge that class fees must be paid in accordance with the terms of this agreement regardless of attendance to the classes and that **NFSD** is not responsible for classes cancelled due to weather.
- e) An N.S.F. charge of \$25.00 will be issued to all returned cheques.
- f) I hereby agree that myself and my child(ren) will behave in a courteous manner and to abide by all Drama School policies including the respectful treatment of all students and staff of both the *Niagara Falls School of Drama* and *Niagara Dance Academy*
- g) I acknowledge that none of the instructors of **NFSD** are qualified to handle children with special needs and that we, the parents, will inform the instructors of any special instructions that relate to my child/student, and that **NFSD** may refuse/terminate enrolment based on a student's behaviour.
- h) I understand that rehearsals and performances of **NFSD** productions are held separately from classes (through *CoLLor Theatrical Productions* its Non-Profit company) and that students involved in such productions will commit themselves fully to the success of the production, by adhering to the instructions laid out in the Cast & Parent Contract, and that failure to do so could lead to dismissal from the cast.
- i) I agree that the *Niagara Falls School of Drama* may use photographs and video of my child for promotional purposes only. (Students will not be identified.)
- j) I acknowledge that the *Niagara Falls School of Drama* and *Niagara Dance Academy* shall not be liable for any claim arising directly or indirectly out of any injury or illness sustained as a result of the use of classes offered, participation in productions, the facilities or the property.
- k) I further acknowledge the *Niagara Falls School of Drama* and *Niagara Dance Academy* will not be responsible for any lost or damaged articles.
